Union Customs Code

The new Union Customs Code will enter in force on 1 May 2016. This will have farreaching consequences on different aspects, such as electronic declarations or inward and outward processing, but certainly in the field of AEO (Authorized Economic Operator).

Although AEO remains a non-mandatory program, companies will no longer be able to appeal to certain customs processes without the AEO certificate.

- transport of goods in temporary storage between Member States
- · centralised clearance
- · exemption from the obligation to physically present goods to the customs officers, provided that a number of additional conditions are met
- · work with self assessments for customs controls
- · reduced deposit for the use of a customer's account for the payment of import duties

In addition, many customs permits will only be granted when a number of, or even all AEO requirements are met. This will actively encourage obtaining the certificate
